



Minority Scholarship Application (2024) Broker course or Designation/Certification

Scholarship:

- Two (2) scholarships will be awarded to minority REALTOR® members of Tri-County Suburban REALTORS®.
- The scholarship may be used to cover <u>a one or two credit broker or designation course</u> up to \$350.00 offered by the Association of REALTORS® school.
- The award has no residual value.
- The scholarship is not transferable and expires on December 31, 2024.
- The scholarship does not apply to online, self-paced courses.

Eligibility:

- Must be a minority REALTOR® member engaged full-time in real estate and have completed at least one (1) Pennsylvania transaction in commercial or residential real estate representing a buyer, seller, landlord or tenant (not yourself or your immediate family).
- Recipient may not have been awarded a TCSR education scholarship within the past 3 years.

Application deadline:

- Email your application to ptansey@tcsr.realtor on or before May 20, 2024.
- Only completed applications will be considered.
- All applicants will be notified of the status of their application within two weeks of the deadline.

If scholarship is awarded:

- Recipient must use the scholarship for courses started and completed on or before December 31, 2024
- Recipient must follow all school policies, including but not limited to, attendance.
