

# 2025 "Making a Difference" Community Service Awards Application

"Making a Difference" Community Service Awards
recognizes REALTOR® members who make an extraordinary impact on their
community through volunteer work.

Multiple winners are selected each year by Association leadership.

These winners will receive a grant for their charity, ranging from \$1,000 - \$10,000.

Winners will receive 2 complimentary tickets to recognized at the 2025 Annual Membership Meeting on October 22<sup>nd</sup>, the Association's largest & most popular event of the year.

## **RULES AND ELIGIBILITY**:

- Nominees must be an active Primary or Secondary REALTOR® member of the Tri-County Suburban REALTORS® in good standing.
- Application deadline: September 30, 2025.
- Nominees should have made a significant impact as a volunteer for a nonprofit organization. Eligible activities are not limited to real estate or housing issues and may include volunteer work done overseas.
  - o Grants must be issued to a US 501(c)3 nonprofit organization.
- Nominees will be judged primarily on the level and impact of personal contribution.
   Nominees should have made a significant contribution of personal time, but contributions of money, materials or other resources will be considered by the task force as well.
- The award is intended to recognize individual contributions, not Association or company-wide efforts. However, if an individual can be singled out as instrumental to the success of a group effort, he or she is eligible.





- If the achievements of two people (such as a married couple or co-founders) of an organization absolutely cannot be separated, they can enter as a pair and their entry will be considered as one.
- Nominees must be able to document the results of their individual involvement through published reports and/or written testimonials from the organization they served or the people they helped.
- REALTORS® may nominate themselves or may be nominated by someone else.
  - A portion of the nominee's work must have taken place within 12 months prior to the nomination deadline; September 30, 2024 – September 30, 2025.


